**Articles of Dissolution**

Pursuant to Section 607.1403 of the Florida Statutes, Atlantic Blue Group, Inc., a Florida corporation, does hereby file these Articles of Dissolution.

1. The name of the corporation is Atlantic Blue Group, Inc., a Florida corporation. Articles of Incorporation were filed on June 6, 2002 and assigned document number P02000062584.

2. The dissolution of Atlantic Blue Group, Inc., a Florida corporation, was approved by the written consents of the holders of its shares of Class B Voting Common Stock as of February 25, 2014.

3. The number of votes cast by the holders of shares of Class B Common Stock in favor of the dissolution was sufficient for approval.

4. The holders of shares of Class B Voting Common Stock were the only voting group required to approve the dissolution.
