**ARTICLE I - NAME**

The name of this corporation is: Premiere Electric & Lighting, Inc.

**ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

**ARTICLE III - PRINCIPAL PLACE OF BUSINESS**

The principal place of business for this corporation shall be 3404 N.E. 2nd Avenue, Ft. Lauderdale, FL 33334.

**ARTICLE IV - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE V - CAPITAL STOCK**

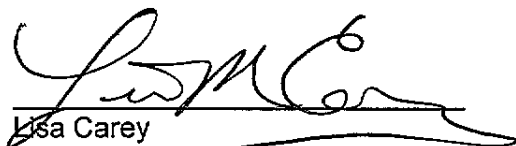
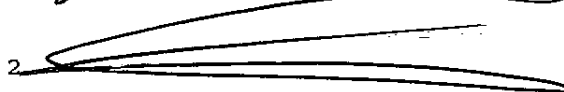
**ARTICLE X - SUB-CHAPTER S AND CHAPTER 1244 PROVISIONS**

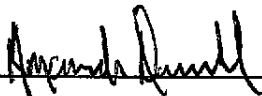
