ARTICLES OF INCORPORATION

OF

### L.R. ANAUEL, INC.

### ARTICLE I - NAME

The name of the corporation is L.R. ANAUEL, INC.

### ARTICLE II - DURATION

This corporation shall have perpetual existence, unless sooner dissolved according to law.


