
To Whom It May Concern,

I am sending my 2003 For Profit Corporation UBR along with the \$150 filing fee. I would appreciate the opportunity to explain the circumstances that led to my late filing.

In March I learned I was pregnant. I was extremely ill and fatigued in the beginning months of pregnancy and could barely make it to my regular job as an eighth grade public school teacher, much less perform the additional tutoring job that supplements my income. I am considered a high-risk pregnancy and have been told to use caution when physically exerting myself. As a single person, my primary job just covers my basic needs (mortgage, auto payment, insurances, utilities, etc.). The additional job of tutoring at my school provides the income that would supply me with funding for the UBR filing fee, but I did not have that income for the past several months due to my condition. I have also spent unexpected medical costs not covered by insurance. That, too, has contributed to my inability to pay the fee until now.

I am now in my second trimester of pregnancy and am feeling much better. I have picked up several summer opportunities to earn money that my school offered and am in the position to send in the \$150 filing fee.
