# ARTICLES OF INCORPORATION

OF

The undersigned, hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

#### **ARTICLE I - NAME:**

The name of the Corporation is YOUR MORTGAGE GROUP, INC.

## **ARTICLE II - PRINCIPAL BUSINESS ADDRESS:**
