The name of the corporation is Maheu Equipment & Fabrication, Inc.

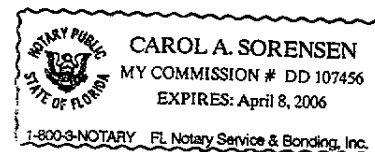


