

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

1. The name of the corporation is: **SHINY FLOOR INC.**

2. Purpose: The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

5. The registered agent of the corporation is David Torchinava and the registered address is 1951 N. Meridian Rd, Apt. 62, Tallahassee, FL 32303.


6. The initial Board of Directors shall have one member whose name and address is as follows:
