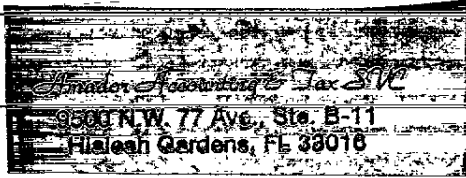

ARTICLE I

NAME

The name of this corporation is AIR CONDITIONED SOLUTIONS, INC. and the mailing address is 8466 N.W. 70 ST, MIAMI, FL 33166

ARTICLE II

NATURE OF BUSINESS

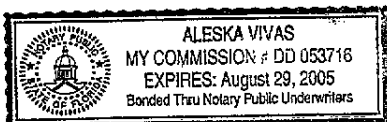


