ARTICLES OF INCORPORATION OF DANIEL SCHOOLER & ASSOCIATES, INC.

ARTICLE I - NAME

The name of this corporation shall be Daniel Schooler & Associates, Inc.

ARTICLE II - PURPOSE

The Corporation may engage in any activity or business under the laws of the United States and the state of Florida's General Corporation Act.
