I, THE UNDERSIGNED, do hereby associate myself for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as follows:

ARTICLE I - NAME

The name of the Corporation shall be:

MADRID REALTY, INC., a Florida corporation

ARTICLE II - PURPOSE

A. To carry on and engage in the business of buying, selling, improving, developing, managing, and maintaining of all types of real and personal property and perform all other acts be necessary or related thereto.
