ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is EK Security Corporation

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be 12075 S.W. 131st Avenue Miami, Florida 33186

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
