I, the undersigned subscriber to these Articles of Incorporation, natural person, competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be ECO TRADING, INC. Its initial principal place of business shall be 460 Lemon Street, Suite A, Tarpon Springs, Florida 34689, with its initial mailing address of P.O. Box 1455, Tarpon Springs, Florida 34688.

ARTICLE II. NATURE OF BUSINESS


