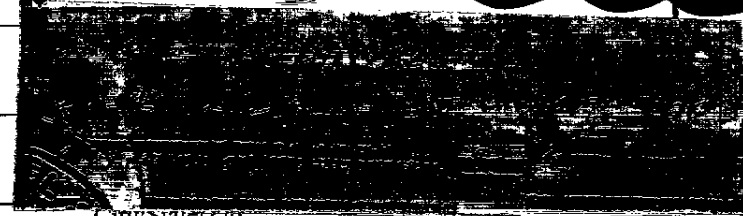

ARTICLE I. NAME

RIGHTS OF EACH ISSUE OF SHARES OF COMMON STOCK.

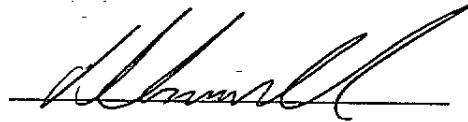
ARTICLE V. TERM OF EXISTENCE

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE.

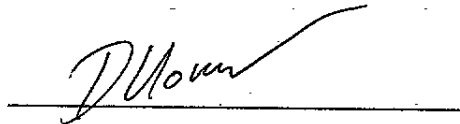
ARTICLE VI. OFFICER AND DIRECTORS

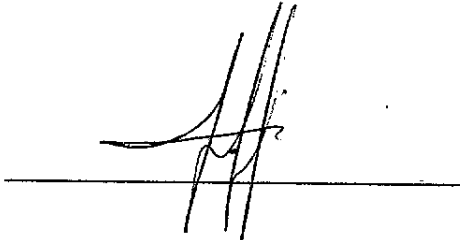
