

**ARTICLES OF INCORPORATION
OF
SUNGHEE AHN, D.M.D., P.A.**

The undersigned, desiring to form a corporation under the provisions of the laws of the State of Florida, hereby make, subscribe and acknowledge before a notary public, and file with the Secretary of State of the State of Florida, the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is: SUNGHEE AHN, D.M.D., P.A.

ARTICLE II - PURPOSE

This corporation is organized for the following purposes:

- (A). To engage in the practice of dental medicine as a professional dental corporation and to carry on services incident thereto. The practice of dentistry is the sole and exclusive professional service to be rendered by this corporation.
- (B). To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.
- (C). The professional services of this corporation shall be carried out only through officers, employees and agents, each of whom is duly authorized to practice dentistry in the State of Florida.






