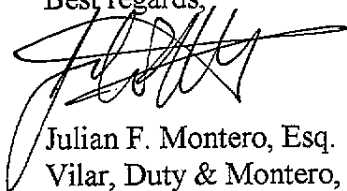

**ARTICLE III**

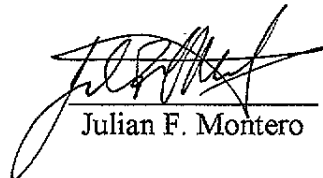
The Corporation is organized for the purpose of transacting any and all lawful activities or business for which corporations may be formed under Chapter 607 of the Florida Statutes.

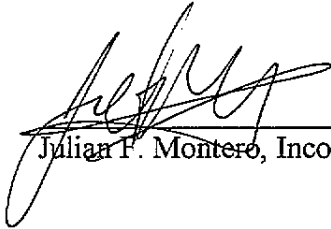
**ARTICLE VI**
