ARTICLE ONE

The name of the corporation is **L.C.L. Investments, Inc.** The principal address of the corporation is: 6400 NW 58th Terrace, Parkland, FL 33067.

The period of its duration is perpetual.

ARTICLE FOUR


The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**
