ARTICLES OF INCORPORATION OF  
TRUPORTIONS, INC.

ARTICLE I - Name

The name of this corporation is TRUPORTIONS, INC.

ARTICLE II - Street Address and Mailing Address

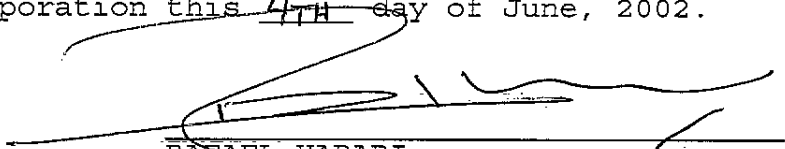

ARTICLE X - Amendment

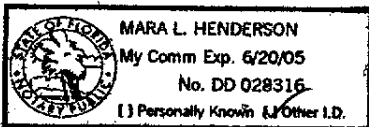

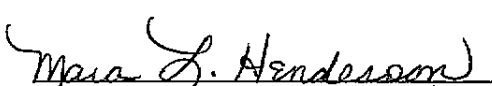
