This Corporation shall have authority to issue One Hundred Thousand (100,000) shares of common stock having a par value of \$0.01 per share.

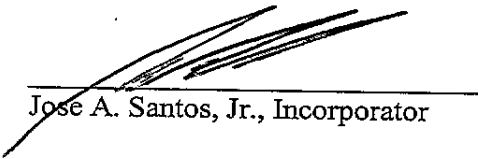
