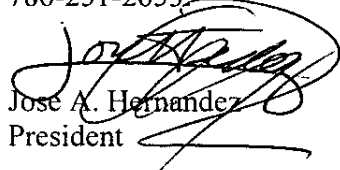
Re: Reinstatement of Corporation
