ARTICLES OF INCORPORATION OF VECTOR ENERGY CORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation is Vector Energy Corporation (hereinafter called the "Corporation").
