**ARTICLES OF INCORPORATION OF

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, under the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be **"Smith & DeShields of Jupiter, Inc."**

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

The total authorized capital stock of this corporation shall be fifty thousand (50,000) shares of common stock at a par value of ten cents (\$.10) per share, fully paid and non-assessable.

ARTICLE V

The business of the corporation shall be conducted by a Board of Directors, the number of members of which shall, except for the initial Board, be determined by the By-Laws, but shall never be fewer than one (1).
