
ARTICLE IX



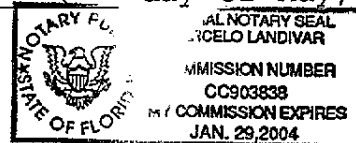
