ARTICLES OF INCORPORATION  
OF  
ARROW TERMITE INC.

ARTICLE I - NAME

The name of this corporation is: ARROW TERMITE INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in the transaction of any and all business permitted under the laws of the United States and of this State.
