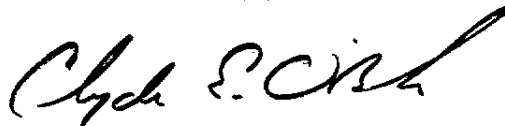

**ARTICLES OF INCORPORATION
OF
VOLUSIA TRANSPORT CORPORATION**

Article I - Name

The name of the corporation is: **Volusia Transport Corporation**

Article II - Duration

This corporation shall exist perpetually.
