#### ARTICLE I. - NAME

The name of this corporation is TWENTY- SEVEN VENTURES, INC.

#### ARTICLE II. - DURATION

This corporation shall have perpetual existence, commencing on June 7, 2002.

#### ARTICLE III. - PURPOSE

This corporation is organized to transact any and all lawful business.
