Article I - Name

The name of this corporation is **JPB PROCARPENTRY, INC.**

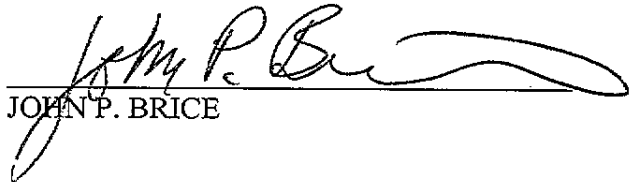

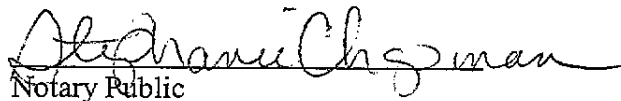
