## ARTICLES OF INCORPORATION OF VAGAMUNDO INTERNATIONAL, INC.

The undersigned, for the purpose of forming a corporation under and pursuant to the provisions of Chapter 302A of the Florida Statues, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I

The name of this corporation shall be Vagamundo International, Inc. 4491 Northwest 36<sup>th</sup> Street

- (e) for any act or omission occurring prior to the date when the provision in the articles eliminating or limiting liability becomes effective."
