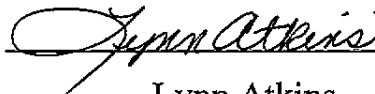
#### **Article IX**

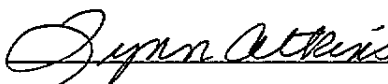
