**ARTICLES OF INCORPORATION
OF
HEARTIFACTS, INC.**

The undersigned, acting as incorporator of HEARTIFACTS, INC. under Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is of HEARTIFACTS, INC. (the "Corporation").

ARTICLE II. MAILING ADDRESS AND OFFICE

The street address of the initial principal office and the mailing address of the Corporation is 14674 S.W. 126 Place, Miami, Florida 33186.

ARTICLE III. REGISTERED AGENT NAME & ADDRESS

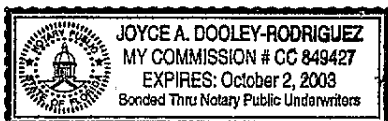
