THE UNDERSIGNED, CLAIRE ISLEY, do hereby execute and acknowledge the following Articles of Incorporation:

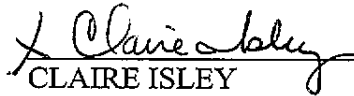
1. The name of the corporation is **ALL FLORIDA DISTRIBUTION, INC.**

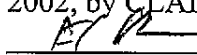

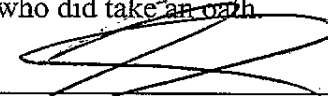

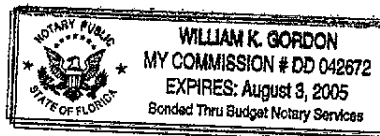
