Dear Sir or Madam:

In regard to your letter dated July 8, 2003, we respectfully request that you file the corporate report without the penalty. The taxpayer was unaware that the report had not been filed.

Circumstances surrounding this incident of non-filing are as follows. The taxpayer had another corporation (staffing the technology field only) that was dissolved filing bankruptcy due to the severe decline in the technology industry over the past years. The corporate report for that corporation was timely filed. A new corporation was formed with a new business outreach and the taxpayer did not realize that a new corporate report needed to be filed. This taxpayer has come into a particularly bad financial decline with the technology crash as well as the economic pressures put on our country due to the 9/11 tragedies.
