ARTICLE I: NAME

The name of the corporation shall be: **RICIGLIANO, INC.**

ARTICLE II - DURATION

The term of existence of this corporation is perpetual.

(A) The private property of the stockholder(s) shall not be subject to the payment of any corporate debts to any extent whatsoever.




