The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this corporation shall be: **R. DEAN FENCING PLUS, INC.**

ARTICLE II

Purposes and Duration
