ARTICLES OF INCORPORATION OF

JUPITER FERTILIZER AND CHEMICAL DISTRIBUTION, INC.

The undersigned hereby makes, subscribes, acknowledges, and files these Articles for the purpose of becoming a corporation under the Laws of the State of Florida.

ARTICLE 1

Name of Corporation

The name of this corporation shall be Jupiter Fertilizer And Chemical Distribution, Inc.

ARTICLE 2

Principal and Mailing Address

The principal office and the mailing address of the corporation shall be located at:

and the mailing address of the corporation shall be:

ARTICLE 3

Perpetual Existence

The corporation shall begin its existence upon the filing of these Articles of Incorporation by the Secretary of the State of Florida and shall have perpetual existence thereafter.

ARTICLE 4

Authorized Business

The corporation shall be authorized to engage in any business or activity permitted under the laws of the State of Florida and of the United States.

ARTICLE 5

No Limitation of Powers

Nothing in these Articles of Incorporation shall be taken to limit the power of this corporation.

ARTICLE 6

Name and Address of Incorporator

The name and address of the incorporator of this corporation is:

ARTICLE 7

ARTICLE 8

Governing Board of Directors

- A. The initial Board of Directors of the corporation shall consist of two (2) directors, but the By-laws may provide for such increase or decrease in number thereof as authorized by law.

ARTICLE 9

Preemptive Rights

The shareholders of the corporation shall have full preemptive rights.

ARTICLE 10

Share Structure

The corporation is authorized to issue an aggregate of 10,000 shares. Such shares shall be of a single class of common stock and shall have a par value of \$1.00.

ARTICLE 11

Transfer of Shares

Before there can be a valid sale or transfer of any of the shares of the corporation by any holder thereof, such holder shall first offer said shares to the corporation and then to the other holders of common shares in the following manner:

- A. Such offering shareholder shall deliver a notice in writing by mail or otherwise to the Secretary of the corporation stating the price, terms, and conditions of such proposed sale or transfer, the number shares to be sold or transferred, and his intention to so sell or transfer such shares. Within thirty (30) days thereafter, the corporation shall have the prior right to purchase such shares so offered at the price and on the terms and conditions stated in the notice; provided, however, that the corporation shall not at any time be permitted to purchase all of its outstanding voting shares. Should the corporation fail to purchase the shares at the expiration of the thirty (30) day period, or prior thereto decline to purchase the shares, the Secretary of the corporation shall, within five (5) days thereafter, mail or deliver to each of the other shareholders of record a copy of the notice given by the shareholder to the Secretary. Such notice may be delivered to the shareholders personally, or may be mailed to them at their last known address as such address may appear on the books of the corporation. Within thirty (30) days after the mailing or delivering of the copies of the orders to the shareholders, any such shareholder or shareholders desiring to acquire any part or all of the shares referred to in the notice shall deliver by mail, or otherwise, to the Secretary of the corporation a written offer or offers, expressed to be acceptable immediately, to purchase a specified number of such shares at the price and on the terms stated in the notice. Each such offer shall be accompanied by the purchase price therefor with authorization to pay such price against delivery of the shares.
- B. If the total number of shares specified in the offers to purchase exceeds the number of shares to be sold or transferred, each offering shareholder shall be entitled to purchase such

- proportion of such share as the number of shares of the corporation which he holds bears to the total number of shares held by all shareholders desiring to purchase the shares.
- C. If all the shares to be sold or transferred are not disposed of under such apportionment, each shareholder desiring to purchase shares in a number in excess of his proportionate share, as provided above, shall be entitled to purchase each proportion of those shares which remain thus undisposed of, as the total number of shares which he holds bears to the total number of shares held by all of the shareholders desiring to purchase shares in excess of those to which they are entitled under such apportionment.
- D. If within said thirty (30) day period, the offer or offers to purchase aggregate less than the number of shares to be sold or transferred, the shareholder desiring to sell or transfer such shares shall not be obligated to accept any such offer or offers and may dispose of all of the shares referred to in this notice to any person or persons whomsoever; provided, however, that he shall not sell or transfer such shares at a lower price or on terms more favorable to the purchaser or transferee than those specified in his notice to the Secretary of the corporation.


