ARTICLE ONE

The name of the Corporation is Long's Home Improvement, Inc.

ARTICLE TWO

The period of its duration is perpetual. The Corporation will commence business on June 25th, 2002. It's federal tax status will be that of a S-Corporation.

ARTICLE THREE

The purpose for which the Corporation is organized is to be a provider of commercial and residential home improvements with related services.
