

ARTICLES OF INCORPORATION  
(Professional Corporation)

The undersigned incorporator, who is duly licensed to practice law in Florida, desiring to form a professional corporation under Chapters 607 and 621 of Florida statutes, adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Professional Corporation shall be Susan P. Bedinghaus, P.A.

ARTICLE II: PURPOSE

The purpose for which this corporation is organized is to practice the profession of law.

Corporate business shall be managed by the shareholders of the corporation, rather than by a board of directors.




