ARTICLES OF INCORPORATION

OF

EAGLE SUBS, INC.

The undersigned Subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form(s) a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this_corporation is EAGLE SUBS, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence and shall be effective upon filing of the Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

- A. To engage in the business of mobile food service and catering together with any and all ancillary and related matters thereto.
- B. To acquire by purchase, lease, or otherwise, lands and interests in lands, and to own, hold, improve, develop, and manage any real estate so acquired, and to erect or cause to be erected on any lands owned, held, or occupied by the corporation,

buildings or other structures, public or private, with appurtenances and to manage, operate, lease, rent, rebuild, enlarge, alter, or improve any buildings or other structures, now or hereafter erected on any lands so owned, held, or occupied, and to encumber or dispose of any lands or interests in lands, and any buildings or other structures, at any time owned or held by the corporation.
