# ARTICLES OF INCORPORATION OF SEONICS INCORPORATED (a corporation for profit)

NISION OF CORFORATION OF JUN 17 MY 10: 3

The undersigned, for the purpose of forming a corporation for profit under the provisions of the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation.

## ARTICLE I NAME

The name of this corporation is **SEONICS INCORPORATED**.

# ARTICLE II DURATION

This corporation shall have perpetual duration. The corporate existence shall begin with the date and time of the filing of these Articles of Incorporation by the Florida Department of State.

## ARTICLE III PURPOSES AND POWERS
