NAME

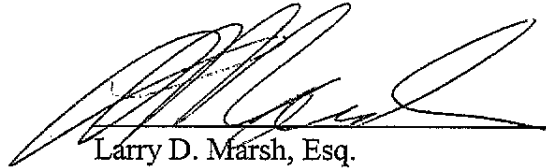

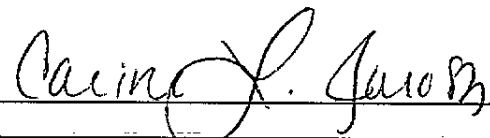

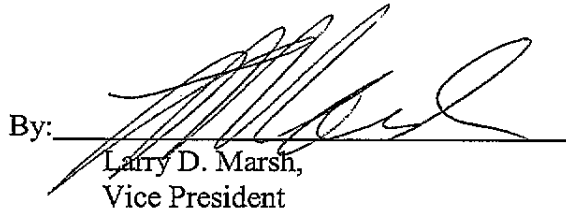
