FOR

**ARTICLE I - NAME**

The name of this corporation shall be Collinsworth Properties, Inc.

**ARTICLE II - DURATION**

The duration of the corporation shall be perpetual.

**ARTICLE III - PURPOSE**


#### ARTICLE XII - AMENDMENT OF ARTICLES


