

This amendment hereby changes the name of the herein corporation to BENTLEY STRIPING, INC.


ARTICLE III

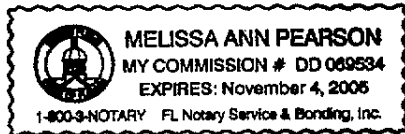
