ARTICLES OF INCORPORATION OF TOP NOTCH LOGISTICS, INC.

The undersigned incorporator of this Corporation under Chapter 607, Florida Statutes, as amended, adopts the following Articles of Incorporation.

ARTICLE I

The name of this Corporation is: TOP NOTCH LOGISTICS, INC.

ARTICLE II

The principal place of business of this Corporation shall be 3830 S.W. 104th Court, Miami, Florida 331365.

The Corporation shall have perpetual existence.
