ARTICLE I. NAME. The name of the corporation shall be ALL-BRITE JANITORIAL SERVICES, INC.

ARTICLE II. DURATION. The corporation shall exist perpetually.

ARTICLE III. PURPOSE. The purpose of this corporation is for janitorial services and for the transaction of any lawful business for which corporations may be incorporated under the law of the State of Florida.
