ARTICLE I, NAME

The name of this corporation is: SPIRIT FILLED VENDING SERVICES, INC.

**ARTICLE II, PRINCIPAL PLACE OF BUSINESS AND
MAILING ADDRESS OF THE CORPORATION**

The principal place of business for Spirit Filled Vending Services, Inc. will be 6117 Shadow Wood Ct. , Orlando, FL 32808. The mailing address will be the same location as the principal place of business.

ARTICLE III, PURPOSE "FOR A PROFESSIONAL CORPORATION"

This corporation is organized exclusively for profit it's scientific purposes, is to maintain and operate a Vending Service company.
