ARTICLES OF INCORPORATION

OF

The ARTICLES OF INCORPORATION of KOUNTRY RENTAL, INC., are as follows:

ARTICLE I.

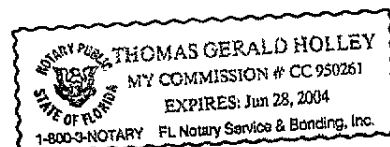
