# ARTICLES OF INCORPORATION

OF

#### Paladin Realty, Inc.

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### **ARTICLE I - Name**

The name of the corporation is: Paladin Realty, Inc.

# ARTICLE II - Principal Office and Mailing Address
