ARTICLES OF INCORPORATION OF

Gina M. Houston Speech - Language Pathology, Inc.

(Pursuant to Chapter 607 and/or 621, Florida Statutes)

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

Article 1. Name

The name of the corporation is Gina M. Houston Speech - Language Pathology, Inc., a Florida Corporation.
