ARTICLE I - NAME

The name of this corporation is Dolphin Installations,
Inc.

ARTICLE II - PRINCIPAL OFFICE

This corporation is organized for the purpose of

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of


