ARTICLE I

Name of Corporation

The name of this corporation shall be known as Beauty Depot Salon, Incorporated, a for profit corporation.

ARTICLE II

Principal Office

The initial address of the principal office or place of business of said forprofit corporation in the State of Florida is 3111 Mahan Drive- Ste. 25, Tallahassee, FL 32308. The Chief Executive Officer of said private organization may move the principal place of business, office, or headquarters to any other address in the City of Tallahassee or the State of Florida.

ARTICLE III

<u>Purpose</u>
