ARTICLES OF INCORPORATION  
OF

The undersigned, for the purposes of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:

ARTICLE I

Corporate Name and Address

The name of the Corporation is SULLIGOLF, INC. and the street address of the Corporation is 2202 N. Westshore Blvd. 5<sup>th</sup> FL, Tampa, FL 33607.

ARTICLE II

Corporate Purposes

The Corporation is organized to transact any and all lawful business authorized by the Florida Business Corporation Act.

ARTICLE III

Authorized Stock

The aggregate number of shares of the Corporation shall be 10,000, all of which are to be voting common stock having a par value of One Cent (\$.01) per share.

ARTICLE IV

Commencement of Existence

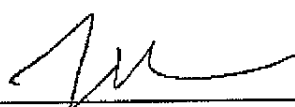
The Corporation shall be deemed to commence on the date of execution of Articles of Incorporation.

The term of existence of the Corporation is perpetual.

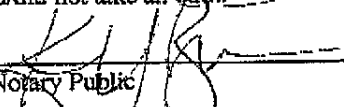
